
CANA Virtual Meeting Platform - Zoom





ASSIGNMENT OF SPACE. Virtual Booth location is assigned on a first come, first-served basis. If spaces selected are taken, CANA management has the right to assign the next best available space. No more than one sponsor company is allowed per sponsorship location.

³AYMENT POLICY. Signed contract and payment is due May 1, 2023. CANA reserves the right to cancel a sponsorship for nonpayment or for misrepresentation of products to be displayed.

CANCELLATION OF SPONSORSHIP BY SPONSOR. All sponsorship cancellations must be submitted to CANA in writing. In the event of a sponsor cancellation sponsorship, the following cancellation policy will apply: - Cancellations made on or before May 1, 2023: An amount equal to 50% of the total sponsorship will be retained by CANA. - No refunds will be given for cancellations received after May 1, 2023.
